Coaching Staff

We are very pleased that Coach Karl Hodgson is returning as head coach of the Water Hogs. He is working on getting the best assistant coaches for this summer. Information on the coaching staff and the Spring Tune Up dates will be on the website when they are finalized.

Parent Informational Meeting

This season we are going to have an informational meeting for new, interested, and returning parents on May 25 at 6 pm in the snack bar area of the club. At this meeting we will explain policies and procedures for members of the team and their families and answer any questions you may have. You will also be able to sign up for your volunteer requirements at that time if you have not already indicated your preferences on your registration form.

New swimmers must try out for the team. Your child must be able to swim one length of the pool (25m) in a front crawl style. (note: we have relaxed the rotary breathing requirement this year) Try-out dates and times will be posted on the web site.

Returning swimmers, you may turn in your registration form and dues at the informational meeting, to the Hog Box starting during Spring Tune up or mail them to my address on the bottom of the registration form. ***Dues must be paid no later than Memorial Day.*** You must register each year to be on the team, we start with a blank roster.

All swimmers must be members in good standing of FHSC, with the club dues paid in full, in order to swim on the team. Failure to pay your club or team dues will result in your child being removed from practice and you will be asked to retrieve your child from the club immediately.

Dues Increase

You will notice that the swim team dues have been raised this year, after many years without an increase. This is for two reasons. First, for the past few years, the number of swimmers has been decreasing, while our expenses have been increasing. We want to maintain the quality program that you have come to expect and we need more money to do that. Second, in addition to the team swim cap, we will be providing a team t-shirt to every swimmer in order to foster additional team unity and spirit. While we regret having to raise team dues during these difficult times, it was necessary and we endeavored to keep our dues in line with neighboring clubs.
